Chapter 17H.010 Street Development Standards

Section 17H.010.160 Traffic Calming

- A. Allowable traffic calming features include traffic circles, chicanes, curb extensions, medians, entry-way treatments, landscaping, turn or access restrictions and other traffic calming features set forth in the Traffic Calming Policy for Residential Streets.
- B. Installation of traffic calming features on existing streets requires a public meeting and a petition representing at least fifty percent plus one of the households in the petition area. This process is outlined in the Traffic Calming Policy for Residential Streets.
- C. Installation of traffic calming features on new streets will be evaluated on a case by case basis and approved by the director of engineering services and the director of streets.
- D. All proposed traffic calming features will be evaluated based on posted speed, traffic volumes, pedestrian generators within the project area, roadway geometry, residential density and collision history as applicable.
- E. Traffic calming features shall not create a street maintenance, safety or parking enforcement problem.

Heather Trautman, Acting Director of Neighborhood Services was the facilitator.

Council members Waldref, Stuckart, Fagan, and Snyder were in attendance.

Photo Red

Photo red is being heard first due to time limits by the council, as some of them cannot stay for the whole meeting. The draft ordinance by Council Salvatori will be on the City Council agenda for advanced agenda review on July 9th and for July 16th council meeting regarding photo red/COPS shop funding issue.

Luke Tolly thought we could skip over the cop shop issue for the photo red dollars.

Sandy Gill thinks photo red money is a separate issue from COPS shop funding.

Councilman Stuckart agreed that there should be a task force regarding the funding before the 16th or some other form of communication with a consensus for each neighborhood.

Hal Ellis thought there was a lack of process on this issue.

Kelly Cruz said the whole reason for photo red was for the money to go to safety issues.

Collegen Gardner wanted to know if there was an alternative.

Shelly O'Rourke informed the group that there was no support from Southgate for changing where the funding is currently allocated.

Paul Kropp stated the PETT committee would have something for the CA meeting on the 13th of July regarding this issue.

Gary Pollard said that we are just beginning the photo red projects and should just see how it works first. Needs to be looked at long term and if the funds were used for the COPS shop they would no longer have funding if the photo red program would be discontinued.

Councilman Snyder wants the issues separated and doesn't want to put the two issues up against each other. Says we need to be accountable to what we told the voters the money would be to.

Colleen Gardner needs clarification on the COPS shops. She thought they weren't going to be permanently funded by the City. She can't get an answer so far.

Luke Tolley wanted to know which neighborhood wanted the photo red money for COPS shop funding

Several responded with South Indian Trail

Heather Trautman summarized that the City Council is requesting a resolution on the use of Photo Red funding be forwarded by the Community Assembly prior to the City Council consideration on July 16th. That the discussion of COPS program funding be discussed separately from the Photo Red funding.

Sandy Gill and Gary Pollard thought that Christie Hamilton, Director of the COPS shops should be at the next

MOTION:

The PeTT Committee hereby proposes the following resolution to the Community Assembly for consideration and adoption at its July 13 meeting:

RESOLVED:

THAT the Community Assembly requests the city council NOT to adopt any amendment to its prior actions on the use of funds from infractions issued with automated traffic safety cameras for the installation of traffic calming measures, and

THAT the Community Assembly understands and determines COPS Shops are not traffic calming measures, and

THAT the Community Assembly supports any and all neighborhood councils in their efforts to install and support a COP Shop to serve their area of the city, and

THAT the Community Assembly requests that members of the city council and the mayor's administration explore options for funding for the startup of a COP Shop facility, and

THAT upon adoption this Community Assembly resolution be conveyed by the Administration Committee to all members of the city council and to the mayor.
