Updates and Comstock Neighborhood Council business:

Meeting call to order at 6:05 PM by Terryl Black.

Terryl Black welcomed all the attendees.

Updates from City Council

No council was present - no report.

Public Safety Report – Officer Ottmar

- Comstock is relatively quiet compared to other neighborhoods on South Hill, especially compared to Lower South Hill nearer to downtown.
- The practice of warming cars running idle unattended is an invitation for theft. Even if the vehicle is equipped with remote start thieves will attempt to steal a car that is running while unattended.
- It was noted that there is an ordinance against idling a car unattended on a public street. The fine is \$136.00
- Crime Stats: There were 286 cars stolen in Spokane for the 2 month period of July through September. Eight of those cars were left running unattended. The recovery rate is approximately 70% at this time. The recovery rate may improve as cars are reported as abandoned.

- A new neighbor from Seattle thanked police for a timely response to his reporting of a vehicle theft.
- The best way to fight crime is to be a good neighbor and watch for any unusual activity in the neighborhood.
- With the lower cost of camera security with motion sensors, it would be a deterrent to property crime to install one.

- Reviewed the city's snow season protocols: Highlights: the season is November 15 through March 15; cars are to be parked on the odd side of the street; trailers/boats/RVs are to be off the streets at all times (during non-snow season, the ordinance for such items is 4 hours of parking.
