Welcome:

Meeting called to order at 6:00 PM by John Schram and welcomed the attendees.

MEETING NOTES:

Neighborhood Resource Officer - Public Safety Report Detective Ty Snider (tsnider@spokanepolice.org 385-1283) and Jake Willard (jrwillard@spokanepolice.org 625-3310):

- John Schram reiterated the usual cautionary items: Lock your cars, don't leave valuables in view in your car, don't leave your garage doors open, don't warm up your cars in the morning, lock your doors, and so forth
- Crime report for the period of 2/20 to 3/20: The handouts related to Detective Ty Snider's report can be accessed on the Spokane City Website. The URL = <u>Crime stats report</u>.
- Lexis/Nexis provides the data information for the police department to track crimes.
- Ty shared two maps, one for downtown, and one for the Comstock neighborhood. As shown on the maps the frequency and location of crimes is mostly downtown. Consequently the police resources have a tendency to be allocated toward downtown.
- Ty discussed some tips on how to prevent being a victim of crime such as; talk with your neighbors if you see anything suspicious, install video surveillance, lock doors and so forth.
- Jake Willard introduced himself and talked about the placement of the mobile radar speed signs. John Schram will send Jake our suggested places for the signs.
- Ty mentioned an interesting documentary titled "Seattle is Dying", It is about the homeless problem in Seattle. It can be viewed on YouTube at Seattle Homeless.

C.O.P.S. presentation by Makaya Judge

Golf Cart Designation Presentation by Jay Affleck;

- Some residents adjacent to the Manito Country Club are requesting that some streets east of Hatch from approximately around 42nd avenue north of the country club and up to about 54th Avenue and including some streets east of Perry to be designated as a golf cart zone. This presentation was an effort to attain feedback from the Comstock Neighborhood.
- It was noted by Jay that in order to drive on the streets the golf cart and driver must meet basic motor vehicle operation standards and the cart must have basic safety features.
- The city already has an ordinance (https://my.spokanecity.org/smc/?Chapter=16A.63) in place that is in effect on the streets adjacent to another golf course in the city.
- The Southgate Neighborhood Council will also be notified by Jay regarding this effort.
- Melissa Wttstruck explained that the approval of the golf cart designation requires a public process that offers other residents on the designated streets the opportunity to provide any concerns they may have.
- The police officers were asked whether there was any known cause to be concerned and they did not see any issues with the designation.
- The Council neighbors present did not object to the efforts to create a designated golf cart area adjacent to the Manito Country Club. A motion was made by John Schram and seconded by Mark Teaford to indicate there was support for the golf cart zone.

Community Assembly Updates

 The neighborhood members at the meeting voted unanimously to support the adoption of the new District Model for CDBG funds allocation process.

Traffic Calming overview:

- The traffic calming committee informed our neighborhood council that the Bernard Street sidewalk request from last year was not approved. As a consequence there is a need to revisit the priority of our 2019 traffic calming requests.
- Since it has been the continual priority of the neighborhood council to complete the side walk project that connects 29th Avenue to High Drive the neighbors voted to re-establish the priorities for the 2019 submission. The Hatch Road speed monitor light will remain our number 1 priority for this year. With the Bernard Street sidewalk as the number 2 priority replacing the 30th Ave sidewalk request, which will be our third priority.

• The neighbors voted to have John Schram investigate if these two sidewalk projects can be submitted to the school funded projects. If the projects fit within the school scope the neighbors present voted to submit both within the school funds, and whichever project does not get funded (or both) we will then submit the projects to the red light fund. As stated in the previous bulleted statement, the Bernard Street sidewalk supersedes the 30th Ave sidewalk proposal.

CHAS Health Presentation: Lindsey Ruivivar (<u>LRuivivar@chas.org</u>) 509-434-0378

- Lindsey spoke about the work related to CHAS Health. It is a non-profit Federally Qualified Health Center (FQHC) that provides medical, dental, pharmacy and behavioral heal services. More information can be found on the web at https://www.chas.org/.
- Lindsey also discussed the organization's efforts to receive funding from the Neighborhood Community Development Program for a capital investment to renovate space at Rogers High School to create a school based Health Center for the students and the residents in the neighborhoods near Rogers High School. The attached pdf provides the application details.
- There was some informational discussion about how this Health Center is a much needed service for the residents in the neighborhoods around Rogers High School and also the need to provide good health care for the students within the school.
