Neighborhood Resource Officer - Public Safety Report Detective Ty Snider (tsnider@spokanepolice.org 385-1283):

- Crime report maps were provided for the periods of 9/18 through 10/16 and 10/23 through 11/20. The attached PDF titled "november crime report maps" is a copy of the report. It was noted by a neighbor that an event that occurred on October 5th was not in the exhibit provided. Ty will check on why it was not in this report.
- Ty also shared an example of a police encounter that occurred in Yakima to illustrate the importance of providing the police with as much details of an incident as possible. This helps the police to respond in the most appropriate manner. The result of this example is that a convicted felon who was illegally in possession of a fire arm was able to have a conviction tossed because the police responded in a manner that did not adhere strictly to the situation. - Statistics reported: Historical Clean/Green roll off event tonnage:
 - 2015 24.72 tons
 - 2016 31.78 tons
 - 2017 23.98 tons
 - 2018 27.23 tons
 - 2019 32.76 tons
 - 2019 Dump Passes: 55 handed out with 3.67 tons dropped off
 - 2019 metal recycling: 1450 pounds
 - Trailer full of hazardous materials taken to the waste to energy processing site

- The total city expenditures for the Clean and Green event and the dump passes during the year amounted to \$7,500.
- \$414 was donated during the Clean and Green event.
- \$22 was obtained from the recycled metals.
- \$67 was spent on supplies
- A net of \$369 was gained.
- Currently \$959 is in the CNC cash box.
- Suggestions were sought from the attendees. Some ideas are as follows:
 - Use the money for Comstock Flags on the light posts along Grand Blvd.
 - Purchase orange flags for the cross walk at Manito Blvd and 29th Ave. John to inquire about the flags with the adjacent neighborhood.

Open Forum for Neighborhood Members

- There was a question and expressed concern about the need for a cross walk across Bernard at 37th Ave. This is needed particularly for the students walking to Jefferson Elementary School.
- A neighbor noted the difficulty of crossing Grand Blvd in the area of 33rd and 34th Ave.
- There was a discussion about traffic calming projects: It was recommended that neighbors
 that have suggestions for traffic calming projects to present their ideas during the January
 meeting because the Comstock Neighbors vote on traffic calming projects during the
 February meeting for submission in early March.
- John Schram showed the South Hill magazine titled "South Bluff Neighbors." John has created a Comstock Neighborhood page within the magazine. The information provided in the November 2019 edition is about Chris Bovey's artwork.
- We discussed the 43rd Ave calming circles. One problem is that traffic appears to be diverting off onto Club Court. SCRIBE'S NOTE: There was an article in the Spokesman-Review about this traffic calming project:

- The new sidewalk ramp on the corner of 32rd and Grand Ave. still has not been remediated.
- Changing High Drive to 20 MPH between 29th Ave and Manito Blvd is still pending.
- There was concern raised about the 5G network infrastructure construction.
