We have made the switch to calling the passes Disposal Passes, at the request of the City Administrator. Communications coming from the City will refer to them as Disposal Passes; we understand you all are used to calling them Dump Passes and that it'll take longer to make the switch over to Disposal Passes when referencing them to community members. We want to clarify that when you see the term Disposal Pass that we are referencing the vouchers formerly known as Dump Passes.

Regarding Spokane residents who don't have access to internet to create a MySpokane City web account:

- There will be an option for accessing a disposal pass for those who do not have access to internet, or don't have the ability to sign up for a city web account.
- A limited number of paper Disposal Passes will be at C.O.P.S. locations. Residents will need to call their C.O.P.S. locations to confirm the hours of operation before going to pick up a Disposal Pass. C.O.P.S. Locations will begin distributing the Disposal Passes on May 17th, but not all locations are open on the 17th, so please go to https://www.spokanecops.org/locations, for listed contact information.

o Postcard Mailings

• We also have confirmed that we'll be able to send out 1 postcard to all Spokane residents alerting them to the Neighborhood Clean Up Program launching. We will stagger those mailings out so that we don't overload the Waste to Energy Facility in the beginning months of the program. Our goal is to have postcards in every mailbox by the end of July.

o Program Launch Date

We have been working with the Web Team to create a user-friendly registration form that can be digitally accessed through the MySpokane.city web account. Due to the many changes that the Clean Up Programming has undergone over the past few weeks due to neighborhood feedback, continued conversations with Web, Public Works, City Council and our City Administrator, the launch of the Clean Up Program's digital platform will be May 17th. The form will be up and running on Monday, May 17th. It will take our system some time to process the requests by verifying resident eligibility for passes, so the first batch of digital passes that will be uploaded for requests received May 17-June 1 will be dated June 1-30 usage.

o Fall Events

We appreciate the feedback that we have received from neighborhoods regarding the desire for fall events. The Office of Neighborhood Services and the Solid Waste Department continue to have discussions about the feasibility of fall (no earlier than September) curbside and roll-off events in neighborhoods. At the May 6th Community Assembly meeting, our Director of Public Works discussed the details around fall event feasibility. We are hoping to be able to hold 9-10 curbside collection events and 6 roll-off events in the fall. Staffing capacity, COVID restrictions and funding may have an impact on these plans, so we ask for your understanding as we begin to look at fall event planning. If you are interested in an event, please indicate what event you would prefer by June 15th (curbside or roll-off). As we anticipate more requests than we'll be able to hold, we will need to work together to determine which ones the City can support. Solid Waste, City Council, and the Office of Neighborhood Services are currently working on sifting through previous program years' data to get an idea of how events will be planned. We do plan to include Clean-Up Coordinator, Neighborhood Council and Community Assembly feedback and assistance during the planning process. Final determination of what events and which neighborhoods will be finalized in August.

- COVID-19:
 - o Updates available here. Vaccines are open to all as of April 15th.
- Comstock Park Irrigation: Due to the January storm our irrigation was knocked out on the mid/east side of the park (where we have to hand water) as well as compromises in other areas to the park. Parks has been approved to bid out fixing the entire mid/east region of the park (which is around the tennis courts to the south to the basketball court and extending west to the ball fields) but this will take a while. Parks will be getting some on-site, signage to help educate that Comstock will be going a bit brown this summer but we are forming our plan to water the trees. The turf we will have to re-grow in spots, but we don't want to lose the trees.

Projects/Programs of Interest

- Housing Action Plan: The City of Spokane is creating the Housing Action Plan to develop policy to
 help increase housing options that are affordable and accessible for people and families of all
 incomes. Following close to a year of stakeholder and community engagement, the City has
 completed the draft Housing Action Plan and it is now available for public review and comment.
 - o The public is invited to review and provide feedback in a variety of ways. Upcoming opportunities as soon as Tuesday. May 18, include online Open Houses, Plan Commission Workshops and a Hearing. To learn more and submit feedback, visit the Spokane Housing Action Plan project page on the City's website.
 - o The Spokane Housing Action Plan provides guidance for City staff, elected officials, and decision-makers to encourage the construction of additional affordable and market-rate housing that meets Spokane's current and future housing needs. The strategies identified in the Housing Action Plan are recommendations, and if each action is undertaken, it will be subject to its own public process of review and adoption.

*Lime Scooters – Spokane has signed a new 2 year contract. It is Code Enforcements responsibility to monitor.

Ryan Quigley, Waste Management:

- *Recycling is now every 2 weeks. Residents can request a larger, 96 gallon bin for free. Call 311 and make the request. Replacements will begin on June 1. Glass is the only item that is not profitable. Contamination in the recycling also drove up prices.
- *May 22 The City is accepting old tires for free.
- *Recycling is also available at the Waste to Energy Plant. Items can be left there for free. Chemicals that are turned into recycling are available for free. Any questions, please contact Ryan at:
