## **Presentations:**

## Ty Snider – Detective:

- Manito Christmas Lights are up and running and people are attending..
- Violent crime for year in entire city is up 10%
- Burglaries up 6 to 15 this month property up 33% for the year in our neighborhood.
- Question: What is happening with the baby moose? The police don't have the tools to handle the wild life.

- Ty Agrees with CM Wilkerson about the community needs to have a voice in the building and location of the precinct.
- Asked Ty: what is the solution for the East Central Precinct. Ty had no specific recommendations, but did state that the current situation is not functioning as it needs to.

# City Council Update (Betsy Wilkerson)

- Prelude by John: asked about the homeless coordinator: The new City CHHS coordinator Jennifer Cerecedes
- Monday night adopted the budget. 1 thing to clarify: NOT defund the police department
- One issue about protection
- Office of civil rights was passed.
- 6% increase to police department
- Looking to get better outcomes with funding distribution related to social services.
- Approved money for homeless issue in reference to tent protest.
- 2022 dashboard to monitor of available beds....
- Burke and Mumm have left the council.
- Betsy discussed her commitment working with the citizens of the city.
- Doug brought up an issue about Police... He is concerned about the direct reports to the chief are not hired by chief but are required to go through the civil service selection process. Doug is concerned that there will be problems if chief does not hire direct reports...
- The supposed issue is that Police and Fire can only have two exempt positions which then require the rest of the department to be processed through civil service. Recent feedback indicates that the Fire Department may be different than Police.
- Question was asked about the East Central Library: Betsy is concerned that the community has a voice in what goes into the building and to best serve the community. It is up in the air i.e. for police, library, community center, etc. It is currently owned by the library. It was noted that the police need to be in a new place, what they have now is not working and is not up to code.

# START: The following are the notes from Co-Chair John Schram:

I would note for the record that CM Wilkerson refused to commit to finding a new home for the police precinct before the use for the old east central library was decided. Moving the police precinct from the current decrepit building unsuitable for the general public to enter (8 years now) into the old library building had always been the general plan by previous administrations but those plans have conveniently been undermined by CM Wilkersons "public outreach" efforts. Note that the other buildings current tennant, the MLK center, wants the police precinct.

I would note for the record that CM Wilkerson initiated a conversation about what she DID NOT say to the police officer requesting her businesses surveillance footage for a recent murder in that neighborhood and she refused multiple direct questions to tell us what she DID SAY. She gave no reasons for not answering the question. This is not how our elected leaders should act as it destroys the fundamental element of trust.

I would note for the record that the CM Wilkerson has admitted to not seeking a legal opinion prior to the City Council teeing up a vote that several police department leaders be placed into the civil service system rather than the current City appointment system in place. The City Council subsequently received legal counsel that found the issue only applied to the Fire Department not the Police Department and has tabled the matter. Ready, Fire, Aim

- Leaf Pickup: City of Spokane crews began leaf pickup activities on City streets on Monday, Nov. 8. Leaf pickup is expected to continue until the middle of December. The crews generally will begin on Spokane's North Side, then moving to the South Hill, and finishing more in the core. Streets cleared of leaves provide safer driving conditions during winter snow and ice. Removing leaves from the streets also helps prevent clogged storm drains. The City's leaf pickup service is intended to remove only the leaves that naturally fall into the streets. **Residents** *should not rake leaves into the street.* A detailed neighborhood leaf pickup schedule is available at on the City's web site at <u>www.my.spokanecity.org/streets/maintenance/leaf-pickup/</u>. An online map at that site also will track the progress of leaf pickup. The need for snow removal can delay this schedule.
  - Being aware of the leaf pickup schedule is helpful because the City is asking residents to move their vehicles from the streets when leaf pickup crews are expected. Crew can work on leaf pickup seven days a week, with activities planned between 7 a.m. and 10 p.m.
  - o Residents do have options for getting rid of the leaves in their yards.
    - The transfer station at the City's Waste to Energy facility, 2900 S. Geiger Blvd. accepts yard waste. The cost to dispose of yard waste is \$57.42 per ton with a minimum of \$6.11 plus a \$2 self-haul transaction fee. That facility is open from 7:30 a.m. to 5 p.m. daily.

The City of Spokane is currently accepting applications to fill three (3) at-large vacancies for the Council Districting Board. Individuals selected for these positions will fill one term, beginning December 1, 2021 and expiring November 30, 2022 after the adoption

- <u>Potholes</u>: If you see a pothole, report it to the City's **Pothole Hotline** at **311**, or for **outside city limits**, **509.755.CITY (2489)**. Street Maintenance Crews are also proactive in looking for potholes and getting them repaired.
- <u>Speeding</u>: If you have a concern about motorists speeding in your neighborhood, please report it to the **Traffic Hotline** at **509.625.4150**. If it is an emergency or in-progress, please call **911**.

- <u>Snow Season Preparation</u>: As the City of Spokane begins preparations for snow season, Parking Services personnel will be educating residents about on-street parking rules for non-passenger vehicles and dedicating resources to resolve complaints about such vehicles throughout the City. Non-passenger vehicles include recreational vehicles, boats, and trailers. Additionally, obstructions like basketball hoops should also be removed from the right-of-way. As a reminder, RVs, boats and trailers cannot exceed 24 hours of continuous on-street parking, according to Spokane Municipal Code (16A.05.310B). The public will see parking enforcement across the City visiting vehicles and placing courtesy notices on them. Parking enforcement can also issue tickets and initiate towing. Press Release
- <u>Winter Shelter Options</u>: Spokane has a regional network of shelter spaces available for use by those needing a safe place to spend the night or relief from the elements during emergencies. Those include shelter for single adults, families, young adults, and youths. Pandemic restrictions are followed in the shelter system. See <u>https://my.spokanecity.org/hazardsheltering/</u> for more information about what is available and where.
- COVID-19 and City Hall: City Hall and other City facilities have reopened to the public and masks are required within City facilities. MySpokane is open from 9am - 12pm and 1pm - 4pm. - Rental Assistance for those affected by Covid-19:

- The City of Spokane was awarded Emergency Rental Assistance (ERA) funds by the U.S. Treasury. These funds are distributed to Family Promise of Spokane, The Carl Maxey Center, and LiveStories to support City of Spokane residents. City residents can visit the <u>Resident Assistance page</u> for direct links to each program.
- <u>City of Spokane Rental Assistance Program powered by LiveStories</u> accommodates any household located within City boundaries. # Other neighborhood Issues

- Brynn Snyder: Issue: Cross walk at 37<sup>th</sup> and Bernard. Fact: 36 students cross there. Currently ranked about 70<sup>th</sup> in the docket of traffic calming. The consensus of the Comstock Neighbors is that this is a critical issue that needs a resolution ASAP. NOTE: This is an issue that has been on our docket for a number of years.
- Betsy Wilkerson will take the initiative to work on the 37<sup>th</sup>/Bernard Cross walk and get the city, SPS, and even the bus transportation involved because they have a bus stop near there.
- Jeff Mergler: stated: 7 of the 8 projects we have for Comstock are related to cross walks. It is probably the highest priority at 37<sup>th</sup>/Bernard.
- Another area of concern: Rose Judge mentioned the intersection of 33<sup>rd</sup> and Lincoln. There is an apparent recklessness of young drivers around the park and at this particular intersection.
- CA Representative voting: Doug Engle was nominated and voted to be the representative with the exception of himself and abstention from Phil Svoboda. Doug does not want to take the position. Brynn Snyder: Has been voted as our Alternate CA representative.
